## THE MINUTES OF THE ORDINARY GENERAL ASSEMBLY OF 2010 OF BIM BİRLEŞİK MAĞAZALAR A.Ş. HELD ON 27.04.2011

Bim Birleşik Mağazalar A.Ş.'s Ordinary General Meeting was held on 27 April 2011, Thursday, at 10.00 hrs at Company's head office at the address Abdurrahmangazi Mah. Ebubekir Cad. No.73 Sancak Samandıra İstanbul under the supervision of Hüseyin Çakmak, the Ministry of Industry and Commerce commissioner appointed by letter number 24969 dated 26.04.2011 from the Istanbul Provincial Directorate of Industry and Commerce.

The invitation for the meeting was announced in Turkish Trade Registry Gazette no 7792 dated 12.04.2011 in compliance with the laws and the articles of association, thereby specifying the date and the agenda of the meeting within the required period.

Upon examination of the list of attendees, it is understood that, from 151.800.000 shares corresponding to 151.800.000 TL capital of the company, 40.467.792 shares were represented in person and 9.992.926 shares were represented by proxy and this way, the meeting quorum required by the laws and articles of association was obtained with total 50.460.718 shares. Upon this, the meeting was opened by the Chairman of the Board, Mustafa Latif TOPBAŞ and the discussion of the agenda started.

1. Election of Prof. Dr. Ekrem PAKDEMİRLİ as the Chairman of the Council of Meeting, Galip AYKAÇ as the vote collector and Haluk DORTLUOĞLU as the secretary was decided by the participants unanimously. Authorization of the Council of Meeting for signing the extraordinary general assembly meeting minutes was decided by majority of the votes of the participants which correspond to 42.498.705 votes.

The balance sheet, income statements that are arranged in compliance with Capital Market Board's Communiqué Series: XI No:29 and the balance sheet, income statements that are arranged in compliance with the legal records were read and discussed. After the voting, the balance sheet and income statements were approved unanimously by 50.460.718 votes.
- 4. According to consolidated financial statements issued in compliance with the accounting standards of Capital Market Board (CMB), it has been observed that the company had concluded its 2010 operating year with the profit of TL 245.640.000 (two hundred and forty five million six hundred and forty thousand TL) after taxation. The General Assembly unanimously decided with 50.460.718 votes to distribute the dividend of gross TL 182.160.000 (one hundred eighty two million one hundred sixty thousand TL) in cash which corresponds to the 120% of the paid-in capital and to allocate an amount of TL 12.393.303 (twelve million three hundred ninety three thousand three hundred and three TL) as 1st Legal Reserve and TL 17.457.000 (seventeen million four hundred fifty seven TL) as 2nd Legal Reserve; to use the "equation of TL 1.- (Nominal value) = 1 piece = 1 Lot" in calculation of the distributable profit in cash and therefore for each fully paid bearer share of TL 1.- to pay a gross=net dividend of TL 1.20 to shareholders whose dividends are not subject to withholding tax and to pay a net dividend of 1,02 (gross TL 1,20) for each share of TL 1.- for other shareholders and to initiate the payment of cash dividends on 17 May 2011, Tuesday.
- 5. On account of their activities in 2010, the acquittal of the Members of the Board of Directors and Auditors is decided by majority of the votes of the participants which correspond to 50.339.736 votes.
  - The shareholders of Ohio School Employees Retirement System, National Elevator Industry Pension Plan voted against this decision (120.982 votes).
- 6. Open election was held for the Members of the Board of Directors of the company. By the majority of votes which correspond to 42.544.876 votes, , Mustafa Latif TOPBAŞ, Ömer Hulusi TOPBAŞ, Zeki Ziya SÖZEN, Yalçın ÖNER and Jozef Wilhelmus Johannes SIMONS were assigned to serve until the next ordinary general assembly and again Ekrem PAKDEMİRLİ and Mahmud Pyirali Kassamali MERALI were elected as independent members assigned to serve until the next ordinary general assembly and entitled to receive a participation fee of net 2.750 TL (two thousand seven hundred fifty TL.)

7. Elections of auditors were held in accordance with the Articles of Association. As a result of open voting, the General Assembly decided with 43.056.238 votes, that is by the majority of the votes, to charge Arif Ateş VURAN and Selahattin TUNCER as auditors until the next Ordinary General Meeting and to pay a monthly net wage of 1.850 TL each.

The shareholder of National Elevator Industry Pension Plan abstained from voting the decision (71.999 votes).

9. The donations and aids of the company for 2010 were presented to the General Assembly.
